Osceola County Pretrial Release is entirely publicly funded. Our operating and capital budget for the fiscal year 2009-2010 is \$584,245.00.

There are NO funds allocated to assisting defendants obtain non-publicly funded release.

Most of Osceola County PTR defendants pay \$10 per month for the use of the jail kiosk. Those individuals ordered to Electronic monitoring pay \$2.70 per day, those on GPS pay \$4.90 per day, those on alcohol monitoring pay \$4.75 per day, and drug tests are \$30.80 and alcohol tests are \$13.20. This money is not revenue. It is paid to the vendor who provides these services.

Osceola County PTR currently employees eight (8) individuals; one (1) Pretrial Release Coordinator, five (5) Pretrial Release Officers, one (1) Home Confinement Officer, and one (1) Senior Office Assistant.

Osceola County Pretrial Release staff interviewed **and/or** assessed 9393 inmates during the calendar year of 2009.

Pretrial Release staff DO NOT make recommendations for Pretrial Release.

Osceola County Pretrial Release DOES NOT use indigence as a determining factor for release.

The following defendants were granted non-secured release who either failed to appear (**FTA**) for scheduled court date (all FTA result in a warrant) or was arrested for another offense (**RRA**) while on pretrial release program in the calendar year 2009: **It must be noted that 50% of those individuals who either failed to appear or were rearrested were on Bond with PTR supervision.**
